

**WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT  
(COVID-19)**

In consideration for BEING ON PREMISES at VISTA CHRISTIAN RETREAT (CAMP VISTA), I, on behalf of myself and any minor child(ren) for whom I have the capacity to contract, hereby acknowledge and agree to the following:

1. I understand the hazards of the novel coronavirus (“COVID-19”) and am familiar with the Centers for Disease Control and Prevention (“CDC”) guideline regarding COVID-19 and CAMP VISTA-COVID-19 new regulations. I acknowledge and understand that the circumstances regarding COVID-19 are changing from day to day, and these changes might not be adopted immediately by CAMP VISTA. I accept full responsibility for familiarizing myself with the most recent updates at [www.campvista.org](http://www.campvista.org) website.
2. Notwithstanding the risks associated with COVID-19, which I readily acknowledge, I hereby willingly choose to participate in CAMP VISTA activities and abide by CAMP VISTA COVID-19 prevention procedures, which include the following:
  - a. I understand that if CAMP VISTA determines that a camper / volunteer/ staff member needs to go home, I as the parent am responsible to pick up that person within 6 hours of being notified.
  - b. I understand that camp will do its best to offer as many activities as possible, but that programs and procedures will look different from past years past due to COVID-19 precautions.
  - c. I understand that CAMP VISTA faces additional costs related to COVID-19, and CAMP VISTA will not issue any refunds for providing own transportation to camp, for the program ending on Friday evening instead of Saturday morning, or for any other costs to parents related to COVID-19.
  - d. I understand that I will provide transportation for my child(ren):
    - For check-in at the camp on Sunday at 3:00PM
    - For check-out from the camp on Friday from 5:00PM to 7:00PM
3. I acknowledge and fully assume the risk of illness or death related to COVID-19 arising from my being on the premises and participating in the CAMP VISTA activities and hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE (on behalf of myself and any minor children from whom I have the capacity to contract) CAMP VISTA, its affiliated companies, owners, officers, directors, agents, and employees, and release CAMP VISTA from any liability related to COVID-19 which might occur as a result my being on the premises and participating in the CAMP VISTA activities.
4. I shall indemnify, defend, and hold harmless CAMP VISTA from and against any and all claims, demands suits, judgments, losses or expense of any nature whatsoever (including, without, limitation, attorney’s fees, costs, and disbursements, whether of in-house or outside counsel, and whether or not an action is brought, on appeal or otherwise), arising from or out of, or relating to, directly or indirectly, the infection of COVID-19 or any other illness or injury.

**In signing this agreement, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it, and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Agreement for full, adequate, and complete consideration, fully intending to be bound by same.**
